It is also notified that at any given point of time, at least one-half of the total members of the ICC shall be women and that the term of members listed at item numbers 1-5 and 9 will be 3 years. Further, while the student members may be from UG, PG or research scholar levels, each of these members is to be elected through transparent democratic procedure for a term of one year from among UG, PG and PhD students.
