Examination passing Criteria for a course (UG2024 batch)

The criteria for passing a course is given as below-

- The student must have minimum 75% attendance of that course.
- Must pass the Internal Assessment (IA) of the course.
- Must pass End Semester Examination of the Course.
- To pass a course, student needs to secure 40% marks in Internal Assessment, 40% marks in Theory and 40% marks in Practical examination separately. For courses without practical, student needs to secure 40% in IA and 40% in End Semester (Theory) separately to pass the course. Course without IA, student needs to secure 40% for all the components of end semester examination.
- To pass a course, all the above criteria (a to d) must be fulfilled.
- Special Points:
 - It is to be noted that if a student fails in any component of End Semester Examination (practical and/or theory) of a course, student needs to appear whole components of the course in End Semester as arrear.
 - If a student fails or is absent in IA of a course, the IA must be passed in the respective semester, provided completes the 75% attendance criteria of the course during the period of study.
 - If a student fails or is absent in IA of a course, he/she cannot appear in the end semester examination of that course.
 - If a student fail or is absent in IA, and appears END semester examination; the End Semester mark will not be carried forward and needs to appear IA and End Semester (including practical if any) in the subsequent semester.
 - If a student passes in IA, but fails in End Semester; the IA mark will be carried forward and need not appear IA examination again.
 - Before filling up the examination form, the students are asked to verify their status regarding attendance and result of internal assessment.
