Admission under Fringe Village Quota
Bhattadev University, Pathsala

This is for information to all concerned that Bhattadev University has made a provision for admission under the **Fringe Village Quota** exclusively for the Under Graduate admission process (2026-2027) during the **Spot Admission Round** only for eligible candidates belonging to villages/localities situated within approximately 5 km radius of the University (Pathsala Campus), with the objective of promoting access to higher education in this area.

Admission Procedure and Conditions :

1. Only one (1) seat per department shall be reserved for applicants belonging to the notified Fringe Villages.
2. Admission under this quota shall be considered **only during the Spot Admission Round** and subject to availability of seats.
3. Selection of candidates shall be made strictly on the basis of **merit** and fulfillment of the eligibility criteria prescribed by the University.
4. Candidates must produce a valid **Domicile Certificate/Residential Proof** issued by the competent authority for verification at the time of admission.
5. The decision of the University authority regarding eligibility and admission shall be final and binding.
